BACKGROUND:

On January 19, 2021, City Council passed an ordinance amending Chapter 12 of the Greensboro Code of Ordinances to prohibit discrimination in Public Accommodations, Employment, and Fair Housing, on the basis of sexual orientation, gender identity or gender expression, or on the basis of hair texture and hairstyles that are commonly associated with race or national origin. This ordinance further amends Chapter 12 to include procedures to enforce these violations and other types of discrimination prohibited by Chapter 12. This ordinance includes a \$500.00 civil

penalty for each violation, and for a continuing violation, each day the violation continues is a separate violation. This ordinance also gives the Human Rights Director the authority to seek equitable enforcement of the discrimination provisions in this ordinance in the Guilford County Superior Court pursuant to N.C.G.S. 160A-175. These enforcement procedures and civil penalties apply to both individuals and businesses.
