#### **PURPOSE**:

To authorize the pass-through payment of \$50,000 from the NC Department of Commerce, One NC Fund Grant for payment to Pactiv LLC.

A budget ordinance needs to be approved by City Council to recognize \$50,000 of revenue from the NC Department of Commerce and to increase the City of Greensboro Economic Development Incentive Grant fund by a like amount for the purpose of making this pass through payment to the incentive grant recipient.

#### **BACKGROUND:**

City Council authorized a \$167,739 economic development incentive for Pactiv LLC on September 15, 2020 and executed an inter local pass-through agreement with the NC Department of Commerce on March 9, 2020 to designate the City as lead agent and facilitate orderly payment from the NC Department of Commerce's One NC Fund to the recipient Pactiv LLC. This incentive

grant represents the full payment the NC Department of Commerce will be making to Pactiv LLC under the incentive grant agreement.

#### **BUDGET IMPACT:**

The attached ordinance recognizes the receipt of additional revenues from the NC Department of Commerce to fund the incentive grant and authorizes a like amount increase to the Economic Development Incentive Grant fund for the payment to the recipient
