**PURPOSE:**

Consider a loan subordination request from the East Market Street Development Corporation as collateral for construction loans.

**BACKGROUND:**

The East Market Street Development Corporation, doing business as East Greensboro NOW, is asking the City to subordinate two loans on property in Jonesboro/Scott Park. The loans were used to purchase property at 304, 306, and 308 Shaw Street and 103 and 107 North Raleigh Street, under an agreement with the City as a step in implementing the Jonesboro/Scott Park Plan. The subordination will facilitate a construction loan to complete two homes in the area damaged by the recent tornado and to build new houses in Jonesboro/Scott Park.

The City partnered with the East Greensboro NOW to create a plan for the Jonesboro/Scott Park neighborhood, which City Council adopted on August 3, 2009. As one of the implementation steps in the plan, City Council entered into a Developers Agreement with East Market Street

Development Corporation on August 3, 2009 with \$500,000 in funding. The agreement allowed the East Greensboro NOW to buy property for the purpose of new home construction, home rehabilitation, either to sell for homeownership or to lease. The construction of the new homes will be done under that agreement.
