PURPOSE:

The City of Greensboro received funding from the North Carolina Department of Transportation in support of the purchase of replacement buses. A resolution needs to be approved to authorize the agreement to accept these funds.

BACKGROUND:

The City of Greensboro received funding in the amount of \$1,768,282 from the Federal Transit Administration (FTA) for the purchase of four (4) replacement 40 foot clean diesel buses. This agreement originally required a local match of \$312,050. The North Carolina Department of Transportation recently approved a state match funding request in the amount of \$145,623. By accepting these funds, the City will reduce the required local match by a like amount.

BUDGET IMPACT:

The North Carolina Department of Transportation will contribute \$145,623 in matching funds to this grant, thereby reducing the City's local match amount.
