PURPOSE:

The bids for Contract 2018-045A, Airpark Water Booster Pump Station Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Jimmy R. Lynch & Sons, Inc. for \$3,969,493.00.

BACKGROUND:

This project consists of the construction of a new water booster station facility on Sharps Airpark Court. The proposed booster station is needed to support increasing water demand and redundancy efforts within the 1120 psi zone area (service area west of NC 68).

The work in this contract consists of the construction of a masonry brick and block water booster station. The work also includes installation of three fixed speed horizontal split case pumps and associated valves and piping.

The bids were opened on September 17, 2021, and the apparent lowest, responsive bidder was Jimmy R. Lynch & Sons, Inc. with a bid of \$3,969,493.00. The MWBE goals for this project are 11.5% MBE and 10.6% WBE. The contractor's commitments are 12.36% MBE and 14.36% WBE.

The other responsive bid received was:

Kiewit Infrastructure South Co. \$4,335,368.00 MBE=11.69% WBE =10.94% Omaha, NE

One other bid was received but was not opened as it was deemed to be non-responsive because it did not meet MWBE goals nor Good Faith Efforts (GFE). An appeal to this determination was made by the contractor. The outcome of this appeal was that the contractor did not meet GFE.

The proposed date for start of construction is December 2021. The proposed date of completion is November 2022.

Funds in the amount of \$3,969,493.00 are budgeted for this project in Water Resources Water Booster Stations account number 503-7031-08.6019 A22060.
