PURPOSE:

The City of Greensboro Parks & Recreation Department is requesting funding for a three-year contract for Sports Officiating Services.

BACKGROUND:

The Parks & Recreation Department is responsible for providing healthy and stimulating recreational activities for the communities of the City of Greensboro. The current contract with Integrity Sports, Inc. will expire on October 31, 2021. Procurement Services issued a Request for Proposals (RFP) to establish a new contract. On July 23, 2021, an RFP was solicited under Event Number 10291 using the Greensboro e-Procurement System (GePS). The GePS solicitation was sent to 789 vendors. The M/WBE office advised that there were no registered M/WBE firms for this service. The City received two responsive bids for this service.

A selection committee reviewed the submitted the responsive bids. The committee evaluated the bids on responsiveness to the specification criteria, qualifications, timeliness, experience, past

performances, and costs. Integrity Sports, Inc. was selected as the best value for the youth and adult basketball events. The second responsive bidder will receive the contract award for all of the other sporting events.

BUDGET IMPACT:

Funding for this service is budgeted under various Parks & Recreation Divisions, depending upon the need, in an estimated annual amount of \$39,900.00 with a total potential contract award amount of \$119,700.00.
