PURPOSE:

The bids for Contract 2014-040 (TIP# C-5555 E), College Road / New Garden Road Sidewalk Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Armen Construction, LLC for \$858,982.00.

BACKGROUND:

This project includes federal/state funding and is subject to the U.S. Department of Transportation Disadvantaged Business Enterprise (DBE) program. The M/WBE Program Plan expressly states, "...the following categories of contracts shall be excluded from the scope and application of this Program Plan: (a) Contracts that are subject to the U.S. Department of Transportation Disadvantaged Business Enterprise Program and Airport Concessions Disadvantaged Business Enterprise Program as set forth in 49 CFR Parts 23 and 26 or any successor regulations or legislation."

The DBE goal for this project is 14.0%. Armen Construction, LLC has committed to a DBE goal of 14.0%.

The work in this contract consists of all labor, equipment, and materials required to install sidewalk along the west side of New Garden Road from Ballinger Road south to West Friendly Avenue. Sidewalk will also be installed along the east side of College Road starting approximately 530 feet south of West Friendly Avenue towards Guida Drive. ADA compliant wheelchair ramps will also be installed and driveways replaced as needed to provide ADA compliant paths along the proposed walk.

The bids were opened on October 28, 2021, and the apparent lowest, responsive bidder was Armen Construction, LLC with a bid of \$858,982.00.

The proposed date for start of construction is February 2022. The proposed date of completion is December 2022.

BUDGET IMPACT:

Funds in the amount of \$858,982.00 are budgeted in two separate accounts. \$728,889.00 is budgeted in the Transportation Department's Street and Sidewalk Capital Project Fund account 401-4565-01.6015 A16085 and \$130,093.00 is budgeted in the Transportation Department's 2008 Transportation Bond Fund account 471-4502-15.6015 A11132.
