PURPOSE:

The Water Resources Department is requesting approval for the Southeast (Water Distribution) Feeder Main Design Contract. City Council approval of Contract 2021-0450 in the amount of \$2,600,000 is requested.

BACKGROUND:

The Southeast Feeder Main Project consists of approx. 46,800LF of 24" ductile iron water main to improve the level of water service within southeast Greensboro. The proposed project will allow drinking water to flow from the Piedmont Triad Regional Water Authority interconnection or from the Townsend Water Treatment Plant thus providing greater redundancy within the distribution system and helping to promote future growth within this corridor. Water Resources will fund the project without the need for assessments.

Hazen and Sawyer, PC is on the City of Greensboro Water Resources On-Call list for Professional Services. The team Hazen and Sayer assembled for the Southeast Feed Main Design Project includes: Stewart Engineering Inc (32.81%), CriTek Engineering Group (8.64%), and Falcon Engineering (6.15%). The overall MBE participation for the contract is 41.45% and the WBE participation is 6.15% of the contract amount. The total M/WBE participation as a percentage of the total contract amount is 47.60%.

BUDGET IMPACT:

Funding in the amount of \$2,600,000 is budgeted in the Water Resources Capital Accounts.
