PURPOSE:

The bids for Contract 2020-007A, Camp Burton Water Main Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Jimmy R. Lynch & Sons, Inc. for \$5,267,309.20.

BACKGROUND:

The project is located in Guilford County, and extends the water main from an existing main at Huffine Mill Road and Ranking Mill Road. The water main will be extended north along Rankin Mill Road and then east along Camp Burton Road to provide fire flow and domestic water for the proposed North Carolina National Guard facility.

Work to be performed under this contract includes, but is not limited to, constructing approximately 11,800 linear feet of 12-inch diameter water main, minor lengths of 8-inch and 6-

inch mains, as well as the installation of necessary fire hydrants, valves, and manholes. The water main will be installed by both open-cut and trenchless construction methods.

The bids were opened on November 22, 2021, and the apparent lowest, responsive bidder was Jimmy R. Lynch & Sons, Inc. with a bid of \$5,267,309.20. The MWBE goals for this project are 15.0% MBE and 24.0% WBE. The contractor's commitments are 14.83% MBE and 3.11% WBE.

The other bids received were:

Two other bids were received but they were not opened. They were both deemed to be non-responsive because they did not meet MWBE goals nor Good Faith Efforts (GFE). An appeal to this determination was made by one of the bidders. The outcome of this appeal was that the contractor did not meet GFE. The other non-responsive bidder did not appeal the original GFE review determination.

The proposed date for start of construction is February 2022. The proposed date of completion is November 2022.
