SUBJECT: M/WBE Memo for Contract 2020-007C - Camp Burton Lift Station, Force

Main, and Gravity Sewer

The M/WBE Office reviewed the documentation submitted for 2020-007C - Camp Burton Lift Station, Force Main, and Gravity Sewer project to determine compliance with the M/WBE Program Plan. The goals established by the Goal Setting Committee were MBE 7.50% and WBE 9.90%. Jimmy R. Lynch & Sons, Inc. (Lynch) submitted affidavit C stating the firm achieved MBE 7.63% and WBE 16.72%. Upon review of the documentation, Lynch achieved MBE 17.89% and WBE 5.53% for a total M/WBE of 23.42%. The company did not meet the WBE goals; however, achieved the 50 GFE Points.

Lynch will be awarded a contract for \$18,697,326.40. The submitted appendices state the firm commits to utilize MBE 15.89% (\$3,368,327.13\*) and WBE 5.54% (\$1,036,339.65) for a total M/WBE percentage of 21.43%. Lynch is not in compliance with the M/WBE Program because the firm did not meet their submitted MBE utilization commitment. The City determined that the firm would not need to make up the shortfall. The following certified firms will be utilized on the project.
