#### **PURPOSE**:

The City of Greensboro Water Resources Department requests city council approval to amend bond funding for the Water Resources Capital Project Revenue Bond Fund budget to fund a change order to Contract 2019-006A, the Reedy Fork Water Line Extension and Sewer Outfall project. The work included in the change order consists of overruns tied to horizontal direction drilling (\$370,000), fittings (\$200,000), jack and bore (\$200,000), rock excavation (\$160,000) and trench bedding (\$100,000). Council approval is requested for a budget ordinance to permit the expenditure of funds.

#### **BACKGROUND:**

The City authorized professional services contract, agenda item 21-0355, with Jimmy R. Lynch & Sons, Inc. in the amount of \$4,643,628.16 on 6/15/2021 for the construction of the Reedy Fork water line. The work in this contract generally consists of installation of 6,822 linear feet of 24-inch ductile iron sanitary sewer outfall line, by open cut, and bore and jack. Additionally, the

work consists of the installation of approximately 6,249 linear feet of 24-inch ductile iron water line and appurtenances with 5,349 feet installed by open cut, and 900 linear feet of 24-inch water line installed by directional drill, connecting to existing water lines near the intersections of Summit Avenue and Reedy Fork Parkway and Brown Summit Road and Chickasha Drive. An ordinance is required to appropriate the necessary funds for this change order.

#### **BUDGET IMPACT:**

This amendment will increase the Water Resources Bond Fund budget by \$1,300,000 from revenue bond funding.
