#### **PURPOSE**:

City Council consideration is requested for a contract for professional services for work implementing the *College Hill Municipal Service District Capital Improvements Plan* 

#### **BACKGROUND:**

As a further step in implementing the *College Hill Municipal Service District Capital Improvements Plan*, the College Hill Neighborhood Association requested the Planning Department to prepare and issue a Request for Proposals for professional services to refurbish and install decorative signage and posts within the Municipal Service District.

An Evaluation Panel, led by the Planning Department, reviewed the qualified proposals based on scoring criteria established in the request for proposals. Having completed its review and evaluation, the Panel determined to recommend awarding this contract to the firm Southern Paint and Waterproofing Co., Inc.

On Wednesday, March 30, pursuant to NCGS §160A-536 (d1), the Historic Preservation Commission of Greensboro held a duly advertised public hearing regarding this contract, and the recommendation for awarding the contract to Southern Paint and Waterproofing Co., Inc.

### **BUDGET IMPACT**:

The contract total is \$24,400 to be drawn from the College Hill Municipal Service District account. The contract will be in force through April 30, 2023.
