PURPOSE:

A budget ordinance is needed to reallocate FY 2021 Section 5307 from a County Project to a City project.

BACKGROUND:

The Federal Transit Administration (FTA) awarded federal funds under the FFY 21 Section 5307 Urbanized Area Formula Grant program to the Greensboro Urban Area. Under the locally adopted Transit Resource Allocation Plan, Guilford County Transportation and Mobility Services (TAMS) was allocated \$35,000 in federal funds to support eligible operating costs. The required County match for this project was \$35,000.

Guilford County TAMS has advised the City they do not have enough eligible expenses and will not expend the funds within the grant cycle. Federal funds in the amount of \$35,000 will be shifted to the City project to support qualifying expenses. The local match for this project will be 8,370. Due to the change in local match, the overall grant budget will be reduced by \$26,250.

BUDGET IMPACT:

The Guilford County TAMS project account will decrease as follows:
