PURPOSE:

Michael L. Brian, is requesting original zoning from County RS-40 (Residential Single Family) and County PI (Public and Institutional) to City R-3 (Residential Single Family -3) for properties located at 4100 Presbyterian Road and a portion of Foust Road Right of Way, generally described as west of Presbyterian Road and south of Foust Road.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its June 21, 2022 meeting.

BACKGROUND:

Following a public hearing on May 16, 2022, the Planning and Zoning Commission voted 9-0 to recommend approval of this request. There was one speaker in favor of this request and none in opposition. (See minutes of the May 16, 2022 Planning and Zoning Commission meeting at
