PURPOSE:

To authorize pass-through payments totaling \$400,000 from the NC Department of Commerce, One NC Fund Grant for payment to The Fresh Market, Inc.

A budget ordinance needs to be approved by City Council to recognize \$400,000 of revenue from the NC Department of Commerce and to increase the City of Greensboro Economic Development Incentive Grant fund by a like amount for the purpose of making pass-through payments to the incentive grant recipient.

BACKGROUND:

City Council authorized a \$301,000 economic development incentive for The Fresh Market Inc. on November 21, 2019 and executed an interlocal pass-through agreement with the NC Department of Commerce on March 9, 2020 to designate the City as lead agent and facilitate orderly payment from the NC Department of Commerce's One NC Fund to the recipient The Fresh

Market Inc. This incentive grant represents the remaining four payments of \$100,000 that the NC Department of Commerce will be making to The Fresh Market, Inc. under the incentive grant agreement.

BUDGET IMPACT:

The attached ordinance recognizes the receipt of additional revenues from the NC Department of Commerce to fund the incentive grant and authorizes a like amount increase to the Economic Development Incentive Grant fund for the payment to the recipient
