SUBJECT: M/WBE Memo for Contract 2019-0330 Fire Station 7, Change Order #3

The M/WBE Office reviewed the change request for 2019-0330 Fire Station 7 CMAR project with Samet Corporation (Samet) to determine continued compliance with the City's M/WBE Program Plan. The contractor is required to maintain the original M/WBE participation throughout the duration of the contract unless approved in advance by the City. The request is for payment for a third party inspections required by the City.

The goals established by the Goal Setting Committee for Fire Station 7 were MBE 25.00% and WBE 20.00%. Samet met the MBE Goal (31.50%); but did not achieve the WBE Goal (3.55%). Council approved the contract award (preconstruction, change order #1 and change order #2) amount of \$8,922,632.34 with a commitment of MBE 28.08% and WBE 5.06%. Change order #3 in the amount of \$68,800.00 will increased the total contract to \$8,991,432.34. The MBE utilization will decreased to 27.87% and the WBE utilization increased to 5.12%. Although the MBE utilization percentage decreases, Samet will maintain the M/WBE utilization amount of \$2,966.234.0. The contract continues to comply with the M/WBE Program Plan and the following firms will be utilized.
