Funding Allocation

General Allocation – "Revenue Loss"

- Formula for calculating revenue loss allocation is provided in U.S. Treasury regulations.
- Provides recipients broad latitude to use funds for the "provision" of government services.
- "General Revenues" Revenues collected by the local government and generated from its underlying economy; various types of tax revenues and other types of revenue available to support government services. Excludes "utility" revenue (water, transit) for calculation purposes.
- Can include, but not limited to, maintenance or pay-go funded building of infrastructure, modernization of cybersecurity, provision of police, fire and other public safety services.

Specific Eligible Uses

- Eligible use examples and descriptions are provided in U. S. Treasury regulations.
- Discussion is grouped into categories:
 - Public Health
 - Economic Impacts
 - Premium Pay
 - Infrastructure

Recommended Strategy for Total \$59.4 Million Award

Use General Allocation of ARPA Funding Allowed Under "Revenue Loss" Category

- Provides for flexibility with funding for a variety of projects and programs
- Reporting requirements are reduced for government services
- Funding through general revenues allows for more efficient administration by City and recipient
- Allows more "direct" dollars to be used on projects

American Rescue Plan Funding Administration

Recommended Strategy for Total \$59.4 Million Award

Use General Allocation of ARPA Funding Allowed Under "Revenue Loss" Category

- Allocation Process: Identify Eligible Government Services
- Most of City's Expenditures Qualify, including Salaries and Benefits
- Identify "Local" Budgeted Expenditures for ARPA reimbursement
- Resulting Savings and General Revenues support Community and City projects approved through the City's ARP review process
- Approach Endorsed by School of Government
- Council Action Adopt Resolution at August 16, 2022 council meeting endorsing staff's recommended allocation strategy.
