PURPOSE:

The City of Greensboro Water Resources Department requests approval to amend bond funding for the Water Resources Capital Project Revenue Bond Fund budget for Construction Change Order #1 for the Liberty Road Water and Sewer Construction Project. Council approval is requested for a budget ordinance to permit the expenditure of funds.

BACKGROUND:

This change order #1 is necessary to cover the cost of additional items and activities needed for the construction of utilities due to unexpected field conditions as well as necessary items not included in the original design.

In order to meet expedited project timelines, the contract was bid and awarded before all applicable permits were acquired. A stipulation of the delayed NCDOT encroachment agreements were that all NCDOT roadway utility crossings would be bored and jacked rather

than open cut as shown on the final design plans. This change order therefore covers the cost of converting all NCDOT roadway open cut crossings to crossings that will be bored under the roadway as per the approved encroachment permits.

BUDGET IMPACT:

This amendment will increase the Water Resources Bond Fund budget by \$1,011,167 from revenue bond funding.
