#### PURPOSE:

The Field Operations Department utilizes various types of rental equipment necessary for daily operations and special projects. We are requesting the usage of the Statewide Term Contract 983A to contract with Herc Rentals, Inc. for the rental of equipment for the period of August 1, 2022- October 31, 2023. The Statewide Term Contract 983A provides several companies such as Herc Rentals, Inc. to provide rental equipment to meet service demands and operational needs of the department. The estimated value for fifteen months with Herc Rentals, Inc. is estimated at \$150,000. The total contract value exceeds \$100,000, which requires City Council approval.

## **BACKGROUND:**

The Field Operations Department has rented equipment for several years through various companies depending on specialized equipment needs. It is necessary to have rental companies available to assist us in handling routine day to day operations and special projects. We do not have the equipment in our fleet due to the costs and maintenance needs for the different types of

equipment requested. In some cases, equipment in our fleet is being repaired and may be down longer due to the type of maintenance or parts necessary to have the equipment operable.

The M/WBE office has reviewed the necessary documentation and determined that there were no M/WBE firms to provide services. The M/WBE office supports the request for the Field Operations Department to utilize the Statewide Term Contract 983A to contract with Herc Rentals, Inc. for rental equipment needs.

#### **BUDGET IMPACT**:

The estimated value for fifteen months is estimated at \$150,000. Funding will be available in General Fund, Stormwater Management Fund, and Solid Waste Management fund budgets. Funding in future years is contingent upon City Council appropriations through the annual budget.
