

**Greensboro ERA Funds Transfer MOU – Amendment 2**  
**Parent Contract No. 90003695**

This Memorandum of Understanding is hereby amended effective **July 14, 2022**.

The Parties mutually agree that, as of the effective date of this amendment, the **following changes are hereby made to the MOU as previously amended**:

In the Terms section, Paragraph 1, entitled “Payment,” is replaced by the following:

1. **Payment.** Guilford County (“County”) agrees to pay to the City of Greensboro (“City”) a sum of money up to \$6,500,000.00 from its available ERA funds to be used exclusively for Rental and Utilities Assistance and consistent with the requirements set forth in all applicable state and federal legislation related to the ERA funds and related contracts the County may have with any state or federal agencies that have provided these additional funds to the County and any revisions made, and guidance issued thereto. An initial payment of \$2,000,000.00 was distributed to the City of Greensboro, upon availability of ERA 1 funding from the State of North Carolina and execution of this Agreement. Further distributions to the City of Greensboro will be made at the County’s sole discretion from the County’s ERA 1 and/or ERA 2 funding allocations based upon monthly reimbursement requests from the City of Greensboro for expenses that meet the funding source requirements and include all required reporting information. Payments to the City of Greensboro will be suspended or terminated if the State of North Carolina, the U.S. Treasury, or other governmental authority suspends payment of funds to or terminates the funding agreement with Guilford County.

In the Terms section, the following additional paragraph is added (Paragraph 13):

13. **Discontinuation of New Application Processing.** City will not process applications for rental or utilities assistance under this Agreement beyond those reported to County as “in progress” as of July 5, 2022 and not transferred to the County without County’s written authorization by its County Manager.

Payments will be structured as a single \$2 million advance with the balance paid on a reimbursement basis at a rate not exceed to \$2 million per calendar month.
