PURPOSE:

The City of Greensboro Coliseum Complex is requesting funding for a two year, with optional one one-year extension contract for the Coliseum Complex and Tanger Center Post Event Seat Area Clean Up Services.

BACKGROUND:

On July 11, 2022, the Procurement Services Division conducted an on-line competitive request for proposals (RFP) for post event seat area clean up services, on behalf of the Coliseum Complex. The purpose of this contract is to provide post event seat area clean-up services after various events at the Coliseum Complex and the Steven Tanger Center for the Performing Arts. A selection committee reviewed the submitted responsive bids. The committee evaluated the bids on responsiveness to the specification criteria, qualifications, timeliness, experience, past performances, and costs. Hopkins Services, Inc. was determined to be the best value and

qualified bidder, and was selected for this work. The M/WBE office was consulted during this process and has concurred with the agreement to award this contract to Hopkins Services, Inc.

BUDGET IMPACT:

Funding for this service is budgeted under account number 521-7535-03.5414 and 522-7535-03.5414, in an estimated annual amount of \$450,000.00 with a total estimated contract award amount of \$1,350,000.00.
