PURPOSE:

The Water Resources Department is requesting approval of an engineering services contract for the influent pumps replacement project. City Council approval in the amount of \$ 425,000 is requested.

BACKGROUND:

There are four influent pumps at the T.Z. Osborne Wastewater Reclamation Facility. All of the pumps are electrically inefficient and have exceeded their expected service life. Each of the pumps are rated for approximately 28 million gallons per day (MGD). The influent pumps are located at the headworks of the plant and are used to supply the treatment train. Pump failures adversely impact the treatment of wastewater which in turn may result in an untreated wastewater discharge. Significant releases result in State issued fines. The Water Resources Department has selected Arcadis G&M of North Carolina, Inc., as one of it on call consultants

due to their demonstrated expertise in large wastewater pump equipment, electrical systems, control systems, and with previous pump project replacements. For this contract, the project team includes Arcadis G&M of North Carolina, Inc. along with CITI Inc., a MBE, with contract utilizations of 2.90%; and Taylor Engineering & Consulting, PLLC, a WBE, with contract utilizations of 2.63%. The total MWBE participation for this contract is 5.53%.

BUDGET IMPACT:

Funding in the amount of \$425,000 is budgeted in the Water Resources Bond Fund.
