PURPOSE:

The Water Resources Department is requesting approval for professional design services for the Wright Avenue and Mayflower Drive Culvert Replacement Project. City Council approval of a contract in the amount of \$213,120 is requested.

BACKGROUND:

The City of Greensboro is responsible for the drainage improvements and maintenance of infrastructure that conveys public runoff. This project addresses flooding and erosion concerns that were originally brought to the City's attention by residents. This project will design improvements to alleviate flooding along College Park Creek downstream of the Warren and Wright intersection by upsizing the stormwater infrastructure at Wright Avenue (at the intersection of Warren Street) and Mayflower Drive (near the intersection with Sylvan Road). This project will provide engineering and design services including topographic survey, geotechnical investigations, design plans (bid documents), cost estimation, and bid support.

Tetra Tech is on the City of Greensboro Water Resources On-Call list for professional services. The team Tetra Tech assembled for the evaluation and design includes: CriTek, a MBE, with contract utilization of 14.1%; Three Oaks, a WBE, with contract utilization of 6.5%; Fleming Engineering, Inc.; and Terracon. The overall M/WBE participation for the contract is 20.6%.

BUDGET IMPACT:

Funding in the amount of \$213,120 is budgeted in the Water Resources Stormwater Capital Improvement Fund.
