PURPOSE:

Nicole and Hatfield Charles are requesting rezoning from **R-5** (Residential Single Family - 5) to **CD-RM-8** (Conditional District Residential Multifamily – 8) for 325 Erwin Street, generally described as south of Erwin Street and east of Randleman Road.

As the decision of the Planning and Zoning Commission was appealed, the City Council will conduct a public hearing to consider and take action on this request at its **September 20, 2022** meeting.

BACKGROUND:

Following a public hearing on August 15, 2022, the Planning and Zoning Commission voted 9-0 to recommend approval of this request. There were no speakers for this item. (See minutes of the August 15, 2022 Planning and Zoning Commission meeting). The decision of the Planning and Zoning Commission was subsequently appealed within the required 10 day appeal period so City

Council will hold an additional public hearing at their September 20, 2022 meeting to consider the request.

This rezoning request includes the following condition:

1. Permitted uses shall be limited to a Daycare Center or a Single Family Dwelling.
