PURPOSE:

Mauro Ruggieri, for Ruggieri Associates, Inc., is requesting rezoning from **R-3** (Residential Single Family - 3) to **RM-5** (Residential Multifamily – 5) for 6101 Brushwood Court, generally described as south of Brushwood Court and Grassy Meadow Court.

As the Planning and Zoning Commission approved this request with less than 6 affirmative votes, the City Council will conduct a public hearing to consider and take action on this request at its **November 15, 2022** meeting.

BACKGROUND:

Following a public hearing on October 17, 2022, the Planning and Zoning Commission voted 5-0 to recommend approval of this request. There was one speaker in favor and none in opposition. (See minutes of the October 17, 2022 Planning and Zoning Commission meeting). Since the Planning and Zoning Commission approved this request with less than 6 affirmative votes the City Council will hold an additional public hearing at their November 15, 2022 meeting to consider the request.
