PURPOSE:

To adopt an ordinance amending Chapter 19 of the Greensboro Code of Ordinances to repeal the Bryan Park Golf Commission

BACKGROUND:

The Bryan Park Golf Commission was established by City Council on November 20, 1989 as an advisory board for the purposes of promoting, supporting, advancing, and strengthening the Bryan Park Complex as a public recreational facility. Established under and regulated by Chapter 19, Article IV of the Greensboro Code of Ordinances, Commission duties were originally intended to include review of Capital Improvement Plan (CIP) and other activities of Lessees, contractors, and agents at the Bryan Park Golf facility; recommendation for acceptance or rejection of any private gift, grant, bequest or devise from any source whatsoever of any real or personal property, including monetary contributions for capital improvements; to advise the City Council concerning any agreements with another entity (public or private) for construction of

golf facilities and the utilization of public and private funds; and to perform such other duties as may be assigned it from time to time by the City Council.

Upon review of the original ordinance establishing the Bryan Park Golf Commission, as well as, attendance records, lack of activity, and board membership vacancies, the Commission no longer exists as it was originally intended. Duties of the Bryan Park Golf Commission duplicate those of the Parks and Recreation Commission, which serves in a much broader and comprehensive advisory role in the interest of the Department and the facilities it manages, including Bryan Park Golf. As such, functions and duties assigned to the Bryan Park Golf Commission can be assigned to and handled by the Parks and Recreation Commission.

There is no requirement in the State enabling law for Parks and Recreation Chapter 160A Article 18 or in the City Charter Section 4.01 requiring a public hearing or publication in order to abolish this type of commission.
