PURPOSE:

Field Operations is requesting City Council adopt a budget ordinance to amend the State, Federal, and Other Grant Fund 220 in an amount of \$40,000 due to increased costs associated with the purchase of off-road equipment for the transfer station.

BACKGROUND:

On November 17, 2021, City Council authorized (resolution 2021-383) Field Operations to prepare and submit a Grant Application to the NC Department of Environmental Quality (NCDEQ), Division of Air Quality (DAQ) for their Mobile Source Diesel Emissions Reduction (DERA) matching funds Grant program.

On March 21, 2022, Field Operations received confirmation of the 2021 DERA grant award to replace one of the requested pieces of off-road equipment. The funding identified the replacement of the transfer station's John Deere 644K with a John Deere 644X. This piece of equipment is nearing its end of life cycle and is scheduled for replacement.

The total cost of the equipment was projected to be \$360,000, of which \$90,000 was from the NCDEQ DERA 2021 grant (25%) and \$270,000 was the City's match which was transferred from the Solid Waste Management Fund 551.

On October 31, 2022, the City received a revised quote from the vendor of \$382,279.87 for the equipment. This revised quote will expire on November 30, 2022.

A budget ordinance to amend the State, Federal, and Other Grant Fund 220 in an amount of \$40,000 from \$360,000 to \$400,000 is necessary to purchase this equipment.

BUDGET IMPACT:

Additional funds for the cash match will be funded through a transfer from the Solid Waste Management fund 551 in the amount of \$30,000. The match from the NCDEQ DERA 2021 State Grant will be increased by \$10,000 from \$90,000 to \$100,000. A budget adjustment is required to complete this transaction.
