**PURPOSE:**

Mercy Hill Church is requesting original zoning from County AG-SP (Agricultural with Special Use Permit), County RS-40-SP (Residential Single Family with Special Use Permit), and County AG (Agricultural) to City CD-PI (Conditional District Public and Institutional) for property located at 1317 Pleasant Ridge Road, generally described as north of Pleasant Ridge Road and east of Brigham Road.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its June 21, 2022 meeting.

**BACKGROUND:**

Following a public hearing on May 16, 2022, the Planning and Zoning Commission voted 9-0 to recommend approval of this request. There were two speakers in favor of this request and one in opposition. (See minutes of the May 16, 2022 Planning and Zoning Commission meeting at

<https://www.greensboro-nc.gov/home/showdocument?id=52999>). This request is associated with a voluntary annexation petition to access City services for a place of religious assembly and associated uses.

This original zoning request includes the following condition:

1. Permitted uses include all uses allowed in the PI zoning district except; Fraternities and Sororities, Correctional Institutions, Passenger Terminals, Shooting Ranges, Archery, Skeet, Commercial Parking Lots, Junked Motor Vehicles, Recycling Collection Points, Satellite Dishes/TV and Radio Antennae Towers, Carnivals and Fairs, Christmas Tree Sales, Trade Shows.
