**PURPOSE:**

The Water Resources Department is requesting approval for Change Order #1 to Contract 2019-0070 for Additional Engineering Services at the Mitchell Water Treatment Plant. City Council approval of a contract in the amount of \$451,200 is requested.

**BACKGROUND:**

The City Council approved a contract with CDM Smith on January 15, 2019 for Residuals and Backwash Treatment management. During the design additional operational areas were identified by City staff and proposed to CDM for incorporation into the design improvements. In order to meet regulatory compliance, CDM was also asked by City staff to take the lead on bidding services that combine designs by other consultants into a single project for construction when the construction of other projects were placed on hold.

CDM Smith, Inc. is on the City of Greensboro's On-Call list for Professional Services. For the additional services, CDM Smith, proposes to utilize Crittek Engineering Group (MBE) for 8.83% of the Change Order #1 amount and Consultant Engineering Services Inc. (WBE) for 8.09% of the Change Order #1 amount. Overall for Contract 2019-0070 the team CDM Smith, Inc. assembled includes JC Waller & Associates (MBE) at 6.82%, Crittek Engineering Group (MBE) at 5.79% and Consultant Engineering Services Inc., (WBE) at 2.32%. The overall participation on the project increased from 14.1% (MBE) to 14.93% (12.61% MBE and 2.32% WBE).

**BUDGET IMPACT:**

Funding in the amount of \$451,200 is budgeted in the Water Resources Capital Improvement Fund.
