PURPOSE:

The Field Operations Department is requesting approval for the 2023 Pavement Condition Survey. City Council approval of professional services Contract 2022-0620 with WithersRavenel, Inc. in the amount of \$314,800.00 is therefore requested.

BACKGROUND:

WithersRavenel, Inc. will be performing the required professional services needed to conduct and report the Greensboro 2023 Pavement Condition Survey. Pavement management is an important function of Field Operations from an aesthetics aspect as well as for maintaining the roadway network. In addition, being efficient in allocating funds for street repairs and repaving contracts is a necessity, but is sometimes difficult due to the variables involved. Performing a Pavement Condition Survey allows an unbiased perspective of the street system as a whole and allows allocation of funding to be applied objectively.

WithersRavenel, Inc. is on the City of Greensboro Engineering and Inspections On-Call list for Professional Services. The team that WithersRavenel, Inc. has assembled for the Greensboro 2023 Pavement Condition Survey includes Crittek Engineering Group, P.C, a MBE located in Guilford County. The MBE participation is 9.53%. There is no WBE participation on this contract.

BUDGET IMPACT:

Funding for this contract will come from the Field Operations Department's Work Management account 101-4301-04.5413 in the amount of \$175,000 and the Streets Projects FY 2023 account in the amount of \$139,800.
