**PURPOSE:**

Publix Super Markets, Inc. is requesting annexation of the property located at 5566 Burlington Road, generally described as south of Burlington Road and south of Birch Creek Road.

As this request is a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its November 15, 2022 meeting.

**BACKGROUND:**

This noncontiguous annexation is within the boundary of Growth Tier 1 on the Anticipated Growth Maps in the Comprehensive Plan.

City water will be available by connecting to the 16-inch line located within Burlington Road. In order for this site to be served with water the owner would be responsible for all costs associated with extending and connecting to the public line.

City sewer will be available by either connecting to the 12-inch outfall or 18-inch outfall that cross the site. In order for this site to be served with sanitary sewer the owner would be responsible for all costs associated with extending and connecting to the public line.

The City's Fire Department notes that this site is currently served by McLeansville Fire Department Station #47 located on Knox Road (east of the site). Upon annexation the site will be served by City Station #57 located on Mount Hope Church Road (southwest of the site). For single unit incidents, service to this location would improve based on personnel numbers. Multi-unit responses would also improve, based on staffing and contract agreements with Whitsett and Guilford County Fire.

The Police Department can provide comparable response service to the property under consideration as of the date of annexation. Additional resources may be required as development on the subject property and/or additional annexation in the general area occurs.

Provision of other City services will involve a travel distance almost equal to that necessary to provide service to the previously-annexed property located to the north and south.

**BUDGET IMPACT:**

Initial service will be absorbed in the budget; future services will have an incremental effect on future budgets.

**RECOMMENDATION / ACTION REQUESTED:**

The Technical Review Committee (TRC) recommended this annexation to the Planning and Zoning Commission and to City Council.

The Planning and Zoning Commission recommended approval of this annexation at its October meeting on a vote of 5-0.

Accordingly, it is recommended that City Council hold a public hearing to receive public comment and to consider adoption of an ordinance annexing the above-mentioned property into the City of Greensboro.
