PURPOSE:

The City of Greensboro Water Resources Department requests council approval to amend bond funding for the Water Resources Capital Project Revenue Bond Fund budget for Power Line Extensions supporting the Greensboro-Randolph Megasite Construction Project. Council approval is requested for a budget ordinance to permit the expenditure of funds.

BACKGROUND:

The City of Greensboro has committed to provide water and sewer service to the Greensboro-Randolph Mega Site (GRMS). Toyota Battery Manufacturing of North Carolina (TBMNC) selected the GRMS as the site of their North American electric battery manufacturing plant. To support TBMNC's manufacturing facility, the City began constructing the Sandy Creek Lift Station. As part of the needs to support the operation of the lift station, the electrical utility lines were required to be upgraded from single phase to three-phase power lines. The utility provider will also provide the underground tap and pad mounted transformer to serve the lift station.

Miscellaneous electrical connections will be needed for two water quality monitoring stations as well. This work is before the electrical power meter and is provided by the utility provider, Duke Energy. Duke Energy is requiring Contribution in Aid of Construction from the City of Greensboro for these requests.

BUDGET IMPACT:

This amendment will increase the Water Resources Bond Fund budget by \$510,000 from revenue bond funding.
