#### **PURPOSE**:

City Council approval is requested for a change order to Contract 2017-0710 with Yates Construction Company, Inc. for the Forest Oaks Loop Feed Water Line Extension Project. This change order for \$80,000 is to account for additional items required during construction.

#### **BACKGROUND:**

This change order is necessary to cover the cost of additional items needed for the construction due to unexpected field conditions as well as cover item overruns specified in the original contract.

Due to unanticipated site conditions, significant overruns were experienced on some bid line items. These items included the need to extend the water line encasement boring length due to

poor soil conditions and encountering excavating additional rock. Additional asphalt beyond the contract amounts was also needed to provide patching and asphalt overlays to the work areas in order to meet NCDOT paving requirements.

City Council originally approved a contract award in the amount of \$2,983,692.07 to Yates Construction Company, Inc. on June 16, 2020. MWBE goals were 3.00% MBE and 4.00% WBE, and Yates Construction Company, Inc. committed to 3.10% MBE participation and 4.16% WBE participation. This change order for \$80,000 increases the total contract award to \$3,063,692.07 and decreases MBE participation to 3.02% and WBE participation to 4.06%.
