PURPOSE:

Water Resources Department is requesting approval for Professional Construction Administration Services Contract 2021-007B for the first phase of water booster station improvements. City Council approval in the amount of \$ 772,521 is requested.

BACKGROUND:

Arcadis G&M of North Carolina Inc. was awarded a design contract on January 19, 2021 and has since completed the design of the Four Farms Water Booster Station and other miscellaneous booster station improvements. As the Engineer of Record, Arcadis will provide the necessary inspection and construction administration services in order to ensure the improvements and new facility are constructed in accordance with the design and to certify as such to the North Carolina Department of Environmental Quality.

The Arcadis project team includes Crittek Engineering Group, P.C. (MBE), SAMR PLCC (MBE) and Stewart Engineering (MBE) with utilizations of 13.39%, 2.52%, and 1.06% respectively. The total MBE participation for this contract is 16.98%.

BUDGET IMPACT:

Funding in the amount of \$772,521 is budgeted in the Water Resources Revenue Bond Fund and Water Resources Capital Improvement Fund.
