PURPOSE:

East Carolina Community Development, Inc. for Evangel Fellowship Word Ministries, Inc. and the City of Greensboro,, is requesting original zoning and rezoning from **County RS-30** (Residential Single Family), **City R-3** (Residential Single Family – 3) and **City R-5** (Residential Single Family – 5) to **City RM-18** (Residential Multifamily - 18) for property located at 2230 East Cone Boulevard, generally described as south of East Cone Boulevard and east of Sixteenth Street.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **December 20, 2022** meeting

BACKGROUND:

Following a public hearing on November 15, 2022, the Planning and Zoning Commission voted 7-0 to recommend approval of this request. There were no speakers on this request. (See minutes
