#### **PURPOSE**:

**County AG** (Agricultural) to **City PNR** (Parkland and Natural Resource Areas) for 5724 North Church Street, generally described as east of North Church Street and south of Air Harbor Road Road.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **December 20, 2022** meeting.

#### **BACKGROUND:**

Following a public hearing on November 15, 2022 the Planning and Zoning Commission voted 7-0 to recommend approval of this request. There were no speakers on this item. (See minutes of the November 15, 2022 Planning and Zoning Commission meeting). This request is associated with an adjacent voluntary annexation petition to access City services for a new single family dwelling. Per N.C.G.S 160A-31(F), property that is owned by a public entity such as the

City of Greensboro or Guilford County may be annexed if said property connects other property petitioning for annexation to the City's primary corporate limits.
