PURPOSE:

The Water Resources Department is requesting approval for the Utility Reimbursement Agreement with the North Carolina Department of Transportation as part of the Norfolk Southern Railroad crossing improvement Project Y-4807B. City Council approval of the agreement in the amount of \$748,077 is request.

BACKGROUND:

The North Carolina Department of Transportation (NCDOT) prepared and adopted plans to make street improvements under Project Y-4807B in Guilford County. The project will include improvements to a Norfolk Southern Railroad crossing on Lowdermilk Street. City Council approval of a Utility Reimbursement Agreement is requested to support design and construction activities related to maintaining reliable and consistent utility service for our customers. NCDOT is responsible for the roadway work while the City is responsible for the utility relocations of the water line infrastructure located within the public right of way.

The Project Y-4807B is subject to the State's Disadvantage Business Enterprise (DBE) Program. Work is reviewed by the State for availability and opportunities for DBE participation.

BUDGET IMPACT:

Funding in the amount of \$748,077 is budgeted in the Water Resources Capital Improvements Fund Account.
