#### **PURPOSE:**

Piedmont Discovery is a free park locator app that allows area residents and visitors to find parks, trails and amenities near them. The City of Greensboro, City of High Point, and Guilford County teamed-up to compile a comprehensive inventory of parks, trails and amenities. Collectively the entities will promote close-to-home opportunities to exercise and experience nature for the community's physical and mental well-being.

#### **BACKGROUND:**

The Piedmont Discovery mobile application is designed to provide a single source of information across multiple governmental jurisdictions for locating a park or trail based on the amenities of the features.

City Council approved the first interlocal agreement on July 17, 2018. Click <u>here</u> to view the interlocal agreement. Piedmont Discovery launched to the public in 2019. As a result of the three

years of implementation the existing interlocal agreement is needed for technology and marketing update. Parks and Recreation current has a budget of \$10,000 for maintenance, updates, and marketing on an annual basis.

The amended and restated interlocal agreement includes the details of the Piedmont Discovery Advisory Board, application, growth and incorporation of other entities, timeline, financial obligations and amendments. The agreement has been reviewed by Legal Departments in Greensboro, High Point, and Guilford County.

Pursuant N.C. General Statute, 160A-461 et seq., Council approval is required in order for an agreement between local government entities to be executed and Board approval from the City of High Point and Guilford County is being sought this in January and February 2023.

## **BUDGET IMPACT**:

Funding for marketing and maintenance is budgeted annually through Parks and Recreation.
