#### **PURPOSE**:

**County RS-30** (Residential Single Family) to **City RM-12** (Residential Multifamily - 12) for a portion of Kallamdale Road Right of Way, generally described as a portion of Kallamdale Road east of Randleman Road.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **March 21, 2023** meeting.

#### **BACKGROUND:**

Following a public hearing on February 20, 2023 the Planning and Zoning Commission voted 9-0 to recommend approval of this request. There were three speakers in favor of this item and none in opposition. (See minutes of the February 20, 2023 Planning and Zoning Commission meeting). This request is associated with an adjacent voluntary annexation petition to access City services for new residential development. Per N.C.G.S 160A-31(F), property that is owned

by a public entity such as the State of North Carolina may be annexed if said property connects other property petitioning for annexation to the City's primary corporate limits
