PURPOSE:

The Property Management Section of the Engineering and Inspections Department is in the process of selling a foreclosure property consisting of a residential lot located 723 Princess Rd, Parcel #56500. City Council approval is requested to proceed with the sale of the property to the highest bidder.

BACKGROUND:

Property Management has advertised this property since December 30th 2022. The highest bid from Lost Boy Holdings, LLC was accepted in accordance with Section 4:122 of the City Code of Ordinances, "Sale of real property by advertisement for bid". The property was recently valued by Sheryl B. Johnson, an appraiser with McNairy & Associates, LLC, at \$14,000. The highest and final bid of \$12,600 was accepted and advertised in the News & Record with a 10 day upset period. This upset period has expired with no further bids.

The property was acquired by a commissioner's deed through the foreclosure process. It has been determined that there is no municipal need for the property. The total area of the lot is 20,038 Sq. Ft. (0.46 acres). The property is zoned R-3, Residential Single-family 3.

BUDGET IMPACT:

The proceeds from the sale of this property will be credited to the Foreclosure Accounts Receivable Account #101-NC-NC.0400 of the General Fund. Once all costs related to advertising, property transfer fees and maintenance are paid, any net remaining amount will be recorded as revenue from the sale of the property.
