**PURPOSE:**

City Council is requested to authorize a contract with the Greensboro Housing Coalition for \$500,000 of American Rescue Plan enabled funding. The funds will provide operating support for the organization.

**BACKGROUND:**

City Council previously approved American Rescue Plan enabled funding to support the operations of the Greensboro Housing Coalition in the amount of \$500,000 on January 3, 2023 through approved Resolution 012-03.

The requested action is to authorize the City Manager to execute contract documents. The award will allow the organization to assist with housing operation needs and provide hotline services to the community.

**BUDGET IMPACT:**

Certain federal funding received by the City of Greensboro from an American Rescue Plan Act grant was used to provide eligible City government services under the revenue loss category of allowable expenditures, in accordance with the U.S. Treasury “Final Rule” guidance. As a result, general revenues of the City were subsequently made available for the City Council to support

various projects identified through the City-wide application and review process conducted in late 2021 and early 2022.
