PURPOSE:

Water Resources Department is requesting approval for an owner advisor professional services support contract for the Phase 1 Incinerator Design Build Project at the T.Z. Osborne Wastewater Treatment Facility. City Council approval of a contract with Hazen and Sawyer, P.C. in the amount of \$379,509 is requested.

BACKGROUND:

The T.Z. Osborne Water Reclamation Facility's Fluidized Bed Incinerator (FBI) #2 is in need of rehabilitation, repairs, and other improvements. The Incinerator improvements are being designed and constructed through a design build alternative delivery method approved by Council on January 18, 2022.

The Incinerator Design Build project will be completed in two phases. Phase 1 scope of services will include a system evaluation, full design services, and early material / equipment procurement in order to minimize schedule delays due to long fabrication lead times. At approximately the 60% engineering design point (likely the end of FY 2024), a Phase II change

order for a Guaranteed Maximum Price (GMP) will be submitted to Council for consideration and approval.

The professional services provided by Hazen and Sawyer, P.C. will include owner advisor support services for the first phase of the project. As Owner Advisor, Hazen will attend meetings/workshops, review design submittals, and provide assistance to the owner through the design build process.

Hazen and Sawyer, P.C. is on the City of Greensboro Water Resources On-Call list for Professional Services. Hazen will be teaming with CriTek Engineering for Phase 1 of the Owners Advisor Contract. CriTek is a local MBE and the MBE commitment is 17.5% of the total contract amount. CriTek is not on the design build team and therefore they do not have a conflict of interest in performing the work under this contract.

BUDGET IMPACT:

Funding in the amount of \$379,509 is budgeted in the Water Resources Revenue Bond Account
