PURPOSE:

City Council approval is requested to convey Temporary Construction and Temporary Access Easements from the City of Greensboro to Piedmont Natural Gas (PNG) in order for (PNG) to perform an operating pressure reconfirmation of its gas line. This reconfirmation is required to comply with federal Pipeline and Hazardous Materials Safety Administration (PHMSA) and North Carolina Utilities Commission (NCUC)'s rules and regulations regarding gas line operation and safety. The project involves excavating near the gas line to install equipment to prevent flow across the gas line to allow for completion of the reconfirmation.

BACKGROUND:

The Temporary Construction and Temporary Access Easements are needed to provide an adequate amount of workspace to allow for PNG to install this equipment so that the project can be completed. The subject gas line is an important source of energy to the citizens of Greensboro, providing space, cooking, and water heating to residences and commercial businesses. The subject property is located at 1944 1996 White Street, Parcel #79311. The property is zoned HI (Heavy Industrial District). The required Temporary Construction and Temporary Access Easements conveyance is an area of approximately 10,820 Sq. Ft. (.249 acre).
