PURPOSE:

City Council approval is requested for a change order to Contract 2016-037A (B-5553) for the Ballinger Road Bridge Replacement Project. This change order for \$375,000.00 is to account for additional work required to complete this project.

BACKGROUND:

This project includes Federal funding and is subject to the U.S. Department of Transportation Disadvantaged Business Enterprise (DBE) program. The M/WBE Program Plan expressly states, "...the following categories of contracts shall be excluded from the scope and application of this Program Plan: (a) Contracts that are subject to the U.S. Department of Transportation Disadvantaged Business Enterprise Program and Airport Concessions Disadvantaged Business Enterprise Program as set forth in 49 CFR Parts 23 and 26 or any successor regulations or legislation."

Due to unanticipated site conditions, significant overruns were experienced on some bid line items. These items included additional stone, segmental gravity retaining walls, and various water line fittings and relocations. In addition, the base price index for asphalt cement increased during the

course of the contract. This change order is necessary to cover the cost of this additional work and the increase in the price of the asphalt cement.

City Council originally approved a contract award in the amount of \$2,298,856.62 to Dane Construction, Inc. on March 16, 2021. This change order for \$375,000.00 increases the total contract award to \$2,673,856.62.

The DBE goal for this project is 8.00%. Dane Construction, Inc. committed to an original contract DBE goal of 8.61%, and has exceeded that commitment to date. This change order includes additional work that will be performed by the DBE subcontractor.

BUDGET IMPACT:

Funds for this change order will come two separate accounts. \$275,000.00 will come from the Transportation Department's Ballinger Road Bridge account 401-45-4599040.6014, and \$100,000.00 will come from the Water Resources' Water Lines 2023 account 503-70-7032101.5615.
