PURPOSE:

To approve the Greensboro/Guilford County Tourism Development Authority ("Authority") Fiscal Year 2023-2024 Budget Ordinance in the amount of \$1,260,000. Authorization by the Greensboro City Council of the Authority's budget amount is an annual requirement.

BACKGROUND:

The budget of the Greensboro/Guilford County Tourism Development Authority is funded from a combination of the County-wide 3% Hotel/Motel Room Occupancy Tax, the Greensboro 3% Hotel/Motel Room Occupancy Tax and other revenue. The budget requires approval by the Authority, Guilford County and the City of Greensboro. The total proposed FY 2023-2024 budget of the Authority is \$6,671,450, of which \$1,260,000 represents projected revenue from the 3% Greensboro Hotel/Motel Room Occupancy Tax. This amount represents 20% of the total estimated City Hotel/Motel Tax levy that is then allocated to the Authority to fund tourism activities and is the portion of the Authority's budget that is subject to approval by City Council.

BUDGET IMPACT:

As authorized by statute, the City's 3% Hotel/Motel Room Occupancy Tax Levy is allocated between the City and the Authority, with the City receiving 80% of the tax proceeds and the Authority receiving 20% of the tax proceeds.
