PURPOSE:

The bids for Contract 2021-011 (TIP# EL-5101 DR), Murrow Boulevard Bridge Repairs Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Smith-Rowe, LLC for \$1,757,087.48.

BACKGROUND:

This project includes federal/state funding and is subject to the U.S. Department of Transportation Disadvantaged Business Enterprise (DBE) program. The M/WBE Program Plan expressly states, "...the following categories of contracts shall be excluded from the scope and application of this Program Plan: (a) Contracts that are subject to the U.S. Department of Transportation Disadvantaged Business Enterprise Program and Airport Concessions Disadvantaged Business Enterprise Program as set forth in 49 CFR Parts 23 and 26 or any successor regulations or legislation."

The DBE goal for this project is 8.0%. Smith-Rowe, LLC has committed to a DBE goal of 8.10%.

Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."

The work in this contract consists of all labor, equipment, and materials required for the removal and replacement of the existing Murrow Boulevard bridge deck over Church Street. This work includes cleaning and painting steel beams and bearings, and performing repairs to the substructure.

The bids were opened on June 29, 2023, and the apparent lowest, responsive bidder was Smith-Rowe, LLC with a bid of \$1,757,087.48.

The other responsive bids received were:

Triangle Grading & Paving	\$1,888,650.37	DBE=8.10%	Burlington, NC
United Infrastructure Group	\$2,040,396.91	DBE=10.22%	Charlotte, NC

The proposed date for start of construction is November 2023. The proposed date of completion is September 2024.

Funds in the amount of \$1,757,087.48 are budgeted in the Transportation Bond Fund account 401-45-4599019.6014.
