#### **PURPOSE:**

Water Resources Department is requesting approval for a Contract 2023-0250 for Construction Administration (CA) and Resident Project Representative (RPR) Engineering Services to support the Townsend Water Treatment Plant (WTP) Phase II Electrical Improvements Construction Manager at Risk (CMAR) construction project. City Council approval of the contract with Arcadis G&M of North Carolina, Inc. for \$3,477,631 is requested.

#### **BACKGROUND:**

The Townsend Water Treatment Plant Phase II Electrical Improvements project was designed by Arcadis G&M of North Carolina, Inc., under contract 2020-0150 that was approved by Council on February 18, 2020. To support the construction phase a contract is required for construction CA and RPR engineering services. The delivery method for this project was approved by Council on September 21, 2021 using a Construction Manager at Risk (CMAR). The Construction Manager for this project is Harper General Contractors, Inc.

Arcadis G&M of North Carolina, Inc., is an on-call professional services consultant for the city of Greensboro Water Resources Department. The team assembled by Arcadis G&M of North Carolina, Inc., for the CA/RPR services includes Critek (MBE) at 13.69%, SAMR, Inc. (MBE)

at 1.60 %, Shermin Ata (WBE) at 0.46%, Taylor Engineering (WBE) at 1.87%. The total MBE participation is 15.29% and the total WBE participation is 2.33%.

### **BUDGET IMPACT**:

Funding in the amount of \$3,477,631 is budgeted in the Water Resources Bond Fund account.
