#### **PURPOSE**:

A resolution needs to be approved to authorize a sidewalk maintenance agreement with NC Department of Transportation for U-4015A Gallimore Dairy Road (SR 1556).

#### **BACKGROUND:**

Project U-4015 is a state funded transportation improvement project to widen Gallimore Dairy Road (SR 1556) between NC 68 and West Market Street into a multi-lane facility. The first phase of the project, U-4015B Airpark Road to West Market Street is complete. The second phase U-4015A from NC 68 to Airpark Road is slated for construction in FY 2024. This municipal agreement pertains to sidewalk maintenance responsibility for sidewalk to be constructed under U-4015A.

Under U-4015A, NCDOT will upgrade and install pedestrian facilities as a part of the widening project, creating safer conditions for pedestrians and providing additional connectivity to existing infrastructure including the Bicentennial Greenway. The northern portion of the project is within the City of Greensboro and the southern portion of the project is the City of High Point. Under this municipal agreement and a corresponding one sent to High Point, NCDOT is responsible for the construction of this project. The municipalities will be responsible for maintenance of the newly

added sidewalks within their respective territories upon project completion, per standard NCDOT practice in municipal areas.

#### **BUDGET IMPACT**:

No additional funds are required to approve this agreement. The City will be responsible for future maintenance expenses.
