PURPOSE:

The Greensboro Police Department has been awarded the Law Enforcement-Based Victim Services Program (LEV Program) Grant in the amount of \$263,096 for the two year grant. A budget ordinance is needed to accept the award.

BACKGROUND:

The U.S. Department of Justice (DOJ), Office for Victims of Crime's (OVC) mission is to enhance the nation's capacity to assist crime victims and provide leadership in changing policies and practices to promote justice and healing for all victims of crime. Through the Victims of Crime Act (VOCA), OVC supports a variety of efforts to improve services and response to victims of crime.

OVC launched the Law Enforcement-Based Victim Services Program (LEV Program) in 2018. The goal is to support law enforcement-based victim services program development in the United States and strengthen their capacity. The International Association of Chiefs of Police (IACP) serves as the training and technical assistance provider for the LEV Program. In this role, the IACP aims to enhance the capacity of law enforcement-based victim services by providing guidance on promising practices and policies to support victims' access to their legal rights and

the services and responses they need. IACP works collaboratively with a team of project partners.

The police department currently employs one non-sworn Victim Support Advocate to assist families of homicide victims. GPD will use the grant funding to hire two additional Victim Support Advocates for nonfatal shooting victims and robbery victims. GPD believes that integrating the victim service non-sworn personnel into the Criminal Investigations Division is a critical component of success. Nonfatal shooting crime victims and robbery victims have many needs including, but not limited to, access to compensation, medical services, rehabilitation services, counseling, and legal assistance. GPD is committed to addressing crime from a whole community, including crime victims, perspective.
