Electrical Improvements Phase II, CMAR Construction and GMP Proposal,

Change Order 1

The M/WBE Office reviewed the documentation submitted for 2020-015A - Townsend Water Treatment Plant Electrical Improvements Phase II, Construction Manager At Risk (CMAR) project with Harper General Contractors to determine continued compliance with the City's M/WBE Program Plan. The contractor is required to meet and maintain M/WBE participation throughout the duration of the contract unless approved in advance by the City. The M/WBE goals established by the Goal Setting Committee for the construction phase of the CMAR were MBE 17.00% and WBE 16.50%. Harper General Contractors did not meet the construction MBE goal; however, did achieve the WBE goal and demonstrated GFE. The M/WBE Office will monitor the CMAR project to ensure it continues to make Good Faith Efforts to try to meet the MBE Goal for the allowance categories.

Harper General Contractors in the preconstruction phase committed to utilizing two M/WBE partners and two protégés on its CMAR team. On September 21, 2021, Council approved to award Harper a contract for \$10,940,245.73 which included a construction allowance for the purchase of a long lead time of \$10,095,407.28. The firm committed to utilizing 23.00% MBEs on the total preconstruction services of \$844,838.45. Change order #1 in the amount of \$44,332,891.29 for the remaining construction phase will increase the total contract value (guaranteed maximum price) to \$55,273,137.02. The firm commits to a total contract utilization of MBE 3.41% (\$1,884,379.84) and WBE 22.09% (12,208,334.75) using the following M/WBE firms:
